Escape Room Terms and Conditions

By signing this form, all group members agree that:

1. They will comply with GPPL's Rules of Conduct, particularly the section related to disruptive behaviour and language:
 - a. Behavior that interferes with any person's comfort and use of the library is not allowed.
 - b. Threatening, abusive, harassing language or behavior toward staff or other users is not allowed.
 - c. No person shall traffic in, consume, or appear to be under the influence of alcohol or illegal drugs and substances.
2. They will not hold GPPL responsible for any accidents or mishaps that occur during the escape room session.
3. They will not take photos of the escape room, nor reveal details of the escape room's puzzles to others.
4. They will be age 8 or older **on the date of the sessions checked above**.
5. A minimum of one group member (Participant #1) will be age 12 or older **on the date of the sessions checked above**.

By signing, all group members also indicate they understand that:

1. They may not register for another session of *Escape Room: Priority Party Planning*.
2. GPPL staff members will not extend time in the escape room for any reason, including late arrivals.
3. GPPL staff members may post the group's name, photo, and escape room results in GPPL, on GPPL's website, and/or GPPL's social media channels.
4. GPPL staff members may edit the group's name to ensure it is family-friendly.

Groups will be registered on a first-come, first-served basis. A GPPL staff member will confirm your registration by e-mail at least four days before your session in the escape room.
